SUBJECT: BHSD – Opening dates for allcove sites: San Jose and Palo Alto

During the Health and Hospital Committee (HHC) Meeting on January 19, 2021, Supervisor Simitian requested as status update from the Behavioral Health Services Department (BHSD) on the definitive date for the opening of the allcove Program locations in Palo Alto and in San Jose. This memo provides the requested information.

BHSD met with staff from the Facilities and Fleet Department (FAF) on January 21, 2021 to receive an updated schedule on the allcove Program activation. FAF shared the updated timeline and the explanation for the delays in the timeline since BHSD and FAF's last report to the HHC on November 4, 2020, refer to LF #103219, *allcove Status Report*. FAF provided the attached report and updated timeline to BHSD.

BHSD will participate in the next scheduled meeting between FAF and the landlord for the allcove San Jose location to discuss the timeline for completion of the construction.

The delays are caused by a 30 delay in the issuance of a building permit by the City of Palo Alto, an increase of 30 days in the construction duration as requested by the landlord/Contractor and an increase in of 2 weeks during the activation period to complete the procurement and installation of end user devices as requested by the user and Technology Services and Solutions (TSS).

FAF continues to work with the Landlord/Contractor team on a schedule of completion and may seek contract remedies if schedule is not forth coming.
