## ECONOMIC IMPACT PAYMENTS PAGOS DE IMPACTO ECONÓMICO

---

The Internal Revenue Service (IRS) may issue you an economic impact payment, also referred to by some as a stimulus payment.

*El Servicio de Impuestos Internos (IRS) puede emitirle un pago por impacto económico, también conocido como un pago de estímulo.*

If you receive a check, it will be secured with your stored property. The check will be given to you upon discharge from custody, or you may request to release your check to an outside party (i.e., family member).

*Si recibe un cheque, se asegurará con su propiedad almacenada. El cheque se le entregará al ser dado de baja de nuestra custodia, o puede solicitar que se le entregue su cheque a una parte externa (es decir, a un miembro familiar suyo).*

If you believe your check is lost or has expired, you can request a replacement (upon discharge from custody) by submitting IRS form 3911. The form can be found on the IRS website at [www.irs.gov](http://www.irs.gov).

*Si cree que su cheque se ha perdido o ha caducado, puede solicitar un reemplazo (al ser dado de baja de nuestra custodia) enviando el formulario 3911 del IRS. El formulario se puede encontrar en el sitio web del IRS en [www.irs.gov](http://www.irs.gov).*

Any mail, including stimulus checks, received by the County of Santa Clara Sheriff's Office, after you are no longer in our custody, will be rejected and returned to the sender.

*Cualquier correo, incluido los cheques de estímulo recibido por el Departamento del Alguacil (Sheriff) de el Condado de Santa Clara, después de que ya no esté bajo nuestra custodia, será rechazado y devuelto al remitente*
