SUBJECT: School Linked Services (SLS) Vendors

During the Board of Supervisors' meeting on August 17, 2021 (Item No. 24), Supervisor Simitian requested that the BHSD provide an off-agenda report to confirm that the SLS community-based contracted providers (CBOs) are familiar with the school districts' communities in which they provide services, to ensure that services are not San Jose centric. SLS providers' locations indicate the CBOs' home base. All SLS programs such as Prevention and Early Intervention Strengthening Families (PEI SF), SLS Behavioral Health (SLS BH), Unconditional Education (UE), and Social Emotional Academic Services (SEAS) are community based and serve students and their families on school campuses, in their home, and in the community.

CBOs meet collaboratively with the school districts at the beginning and throughout the school year to discuss emerging needs, behavioral and emotional trends, identify topics for Tier 1 through 3 supports and services, and develop a plan to ensure community and school needs are met. CBOs participate in the campus collaborative meetings with other CBOs that serve the students in the school district. For example, Uplift Family Services (UFS) serves Mountain View Los Altos (MVLA) and Mountain View Whisman, and a monthly collaboration meeting is held with all providers including UFS, Community Health Awareness Council (CHAC), Children's Health Council (CHC), and the Challenge Team with MVLA to coordinate services, understand community and school needs and build partnerships to support the success of students. CBOs have served these communities for several years and are familiar with the communities in which they provide services. Their direct service providers identify and build relationships with other community organizations, such as Community Services Agency of Mountain View, Los Altos, and Los Altos Hills, Hope's Corner, Project Safety Net, and Saint Athanasius Parish, in which they will refer families for additional community resources such as food, COVID-19 relief support, resource navigation, and rent and utilities assistance. CBOs participate in campus collaborative meetings that include school administrators, faculty, parents, students, community members and other CBOs. Participants provide in-depth knowledge on emerging needs within the community and school district. The table below lists all SLS providers, office location, program and school districts.
